

Vivid Bonus Program for Freelancer Customers

1. Prerequisites

- Every existing **freelancer customer** of Vivid Money who holds a freelance account with Vivid Money ("**Eligible Freelancer**") is entitled to participate in the Vivid Bonus Program for Freelancer Customers.
- Every Eligible Freelancer is entitled to receive increased Cashback on all card purchases for both Prime and Standard Freelancers.
- The Cashback for Eligible Freelancers has the following rates: 1% (one percent) on all card purchases for Standard Plan; 2% (two percent) for Prime Plan.
- Each Eligible Freelancer receives a double cashback on all card purchases and Super Deals as a bonus (**together "Referral Bonus"**) for a period of 30 (thirty) days ("**Bonus Period**") from Vivid Money for each successful referral invitation of a new private customer, who is not an **Eligible Customer** of Vivid Money at this point of time ("**New Customer**"). A referral is only deemed successful if the New Customer follows the referral link, which the Eligible Freelancer has sent him, enters his email address and applies for the opening a bank account. The Eligible Freelancer will be awarded with a Referral Bonus, if the New Customer makes 3 (three) offline card payments equaling EUR 10 (ten) or more for each transaction ("**Transaction**") on 3 (three) different days within 90 (ninety) days after opening an account with Vivid Money.
- The Transaction of the New Customer must be successfully performed in order for the Eligible Freelancer to be awarded with the Referral Bonus.
- Each Transaction must be at least in the amount of EUR 10 (ten).
- Each New Customer receives a double cashback bonus for the same period of 30 (thirty) days at the day of account opening with Vivid Money.
- The Eligible Freelancer may get only one Referral Bonus for a first invited New Customer. Every new successful invitation gives to the Eligible Freelancer additional Bonus Period for the initial Referral Bonus.
- The maximum Bonus Period is 300 (three hundred) days. Therefore, an Eligible Freelancer may invite a maximum 10 (ten) New Customers.
- Please note that after 5 (five) successful invitations of New Customers an Eligible Freelancer becomes entitled to participate in the Vivid Ambassador Program. During the Eligible Freelancer's participation in the Ambassador's Program the Referral Bonus is not applicable for him/her. Once the Vivid Ambassador Program is terminated an Eligible Freelancer is entitled to participate again in the Vivid Bonus Program for Freelancers.
- The Vivid Ambassador Program is applicable only for certain countries.
- Please note that a maximum number of 10 (ten) invitations via the referral link is applicable for one client notwithstanding the amount of freelancer/private pockets he/she has opened. Therefore, the referral link is not applicable for every new pocket.

2. Double Cashback and Super Deals for Freelancers

- The Double Cashback on all card purchases for Standard and Prime Freelancers have following rates:
- Standard Plan: 2% (one percent) for all card purchases;
- Prime Plan: 4% (three percent) for all card purchases.
- The Double Cashback for Vivid Travel have following rates:
- Standard Plan: 2% (two percent) cashback for non-euro card payments.
- Prime Plan: 4% (four percent) cashback for non-euro card payments.

3. Miscellaneous

- The Vivid Bonus Program for Freelancer Customers is a bonus program for existing freelancer customers of Vivid Money.
- If the Transaction of the New Customer for which the Referral Bonus has been granted to the customer is cancelled or if the Transaction of the New Customer for which the Referral Bonus has been granted to the customer is reversed (e.g. by return of the purchased goods by the customer) as well as in the event of misuse or fraud by the customer or the New Customer, Vivid Money reserves the right to cancel the corresponding Referral Bonus.
- In the event of incorrect granting of the Referral Bonus to the Eligible Freelancer for technical reasons, Vivid Money reserves the right to cancel the corresponding Referral Bonus in order to rectify the incorrect Referral Bonus.
- Referral Bonus is not transferable.
- Participation in the Vivid Bonus Program for Freelancer Customers can be terminated by the Eligible Freelancer at any time without any notice period.
- In the event of misuse of the Vivid Bonus Program for Freelancers by an Eligible Freelancer or fraud of an Eligible Freelancer in connection with the Vivid Bonus Program for Freelancer Customers, Vivid Money can immediately terminate the participation of that customer in the Vivid Bonus Program for Freelancer Customers.
- Changes or amendments to the prerequisites for the Vivid Bonus Program for Freelancer Customers or the termination of the Program shall be possible for Vivid Money upon notification without observing any notice period.
