

## Vivid Increased Cashback Campaign

### 1. Prerequisites

- Every existing private customer of Vivid Money who holds an account with Vivid Money ("**Eligible Customer**") is entitled to participate in the Vivid Increased Cashback Campaign.
- Every Eligible Customer is entitled to receive increased Cashback on all card purchases for both Prime and Standard plan under the Vivid Increased Cashback Campaign.
- Each Eligible Customer receives an increased cashback on all card purchases as a bonus for a period of 30 (thirty) days and Super Deals for a period of 30 (thirty) days from Vivid Money for each successful referral invitation of a new private customer, who is not an Eligible Customer of Vivid Money at this point of time ("**New Customer**"). A referral is only deemed successful if the New Customer follows the referral link, which the Eligible Customer has sent, enters the email address and applies for the opening a bank account. The Eligible Customer will be awarded with a bonus, if the New Customer makes 3 (three) offline card payments equaling EUR 30 (thirty) or more for each transaction ("**Transaction**") on 3 (three) different days within 90 (ninety) days after opening an account with Vivid Money.
- The New Customer receives an increased cashback as a bonus immediately after the account opening.
- Please note that New Customer must open an account with Vivid Money during the Vivid Increased Cashback Campaign period. The Transaction of the New Customer must be successfully performed in order for the Eligible Customer to be awarded with the Referral Bonus.
- Each Transaction must be at least in the amount of EUR 10 (ten).
- Each New Customer receives an increased cashback bonus for the same period of 30 (thirty) days at the day of account opening with Vivid Money.
- Eligible Customer may participate in the Vivid Increased Cashback Campaign more than once. For every successful New Customer, the Eligible Customer receives a bonus for another 30 (thirty) days period.
- The Vivid Increased Cashback Campaign begins on 23.09.2022 and ends on 07.10.2022.
- Please note participation in any other Vivid's Bonus programm(s) with an increased cashback terminates upon participation in the Vivid Increased Cashback Campaign. However upon termination of the Vivid Increased Cashback Campaign the other Vivid Cashback Program (if any) will continue to be active for the remaining period.
- The Vivid Increased Cashback Campaign is applicable only for certain countries.

### 2. Increased cashback under the program

- The increased cashback on all card purchases for Standard and Prime plans have following rates:
- Standard Plan: 5% (five percent) for all card purchases;
- Prime Plan: 5% (five percent) for all card purchases.

- The Increased Cashback for Vivid Travel have following rates:
- Standard Customer: 5% (five percent) cashback for non-euro card payments.
- Prime Customer: 5% (five percent) cashback for non-euro card payments.

### **3. Miscellaneous**

- The Vivid Increased Cashback Campaign is a bonus program for existing private customers of Vivid Money.
- If the Transaction of the New Customer for which the bonus has been granted to the customer is cancelled or if the Transaction of the New Customer for which the bonus has been granted to the customer is reversed (e.g. by return of the purchased goods by the customer) as well as in the event of misuse or fraud by the customer or the New Customer, Vivid Money reserves the right to cancel the corresponding bonus.
- In the event of incorrect granting of the bonus to the Eligible Customer for technical reasons, Vivid Money reserves the right to cancel the corresponding bonus in order to rectify the incorrect bonus.
- The bonus under the program is not transferable.
- Participation in the Vivid Increased Cashback Campaign can be terminated by the Eligible Customer at any time without any notice period.
- In the event of misuse of the Vivid Increased Cashback Campaign by an Eligible Customer or fraud of an Eligible Customer in connection with the Vivid Increased Cashback Campaign for referrals, Vivid Money can immediately terminate the participation of that customer in the Vivid Increased Cashback Campaign for referrals.
- Changes or amendments to the prerequisites for the Vivid Increased Cashback Campaign for referrals or the termination of the Campaign shall be possible for Vivid Money upon notification without observing any notice period.
